Town Center Plan 1995 Goal

A mixed-use area with retail and pedestrian activity, residential, commercial, cultural, recreational, and entertainment uses.



Objective: Establish a Town Center with a Commercial Area.

- Rural/mountain character.
- A network of pedestrian & bicycle paths which link residential neighborhoods with open space, community

facilities, and commercial areas.

- Provide housing for seniors.
- Promote historic and cultural resources.

Today: Town Center Main Street & Rt. 515 is stagnant








No water lines-Route 515

- •Upgrade water wells
 - •Increase volume & pressure to supply H2O to TC
 - •H2O for fire suppression systems
 - •Increase sewer flow to stabilize rates


Tasks

- Redevelopment designation by the Division of Community Affairs
- Negotiate with Suez for upgrades to infrastructure and franchise.
- Council support to pass bond ordinance for water.
- Amendment to Twp. Ordinance 13-04 to allow craft breweries, wineries, distilleries and ABC licensed establishments. (Accomplished)

Tasks: Develop Vacant/Underutilized Properties

- Municipally owned properties should be aggressively managed and marketed.
 - Sell Township underutilized properties.
 - Develop TWP. Black Creek lot (15 acres) for trails, art walk & parking.
- Connect the Town Center and resorts via bikeway/trail system including sidewalks on paved roadways.


